Challenge

Financing was the critical barrier standing in the way of a global manufacturer's rooftop solar project at one of its California facilities. Ally Energy Solutions had the skills, staff, and materials, but the customer lacked upfront capital to move forward. At the same time, the customer was committed to addressing climate change, reducing GHG emissions, and optimizing operating assets across its portfolio.

Solution

With capital from Redaptive and turnkey delivery by Ally, the team completed a 901-kW rooftop solar installation with zero upfront cost to the customer. The system is expected to generate 1.4 million kWh in its first year, meeting 57% of the facility's energy needs and cutting 322.8 metric tons of emissions.
